

CONSENT TO PERSONAL DATA PROCESSING

This consent to personal data processing is developed in accordance with the legislation of the Russian Federation.

By joining this Consent and leaving your data on the website <https://ярмарка29.рф> (hereinafter referred to as the Site), by filling in the online application (registration) fields, the User expresses Consent to consent to the processing of personal data and its transfer to the operator of personal data processing - GAU AO "Dom predprinimatelya" (12 Obvodniy kanal, Arkhangelsk, Russian Federation, office 501) (hereinafter referred to as the Operator), to which the Site belongs, on the following terms.

The user:

- confirms that all data specified by him belongs personally to him;
- confirms and acknowledges that he has carefully read the Consent and the conditions of his personal data processing specified by him in the fields of the online application (registration), the text of the Consent and the conditions of personal data processing are clear to him;
- Consents to personal data processing without reservations and limitations (hereinafter - Consent). The moment of accepting the Consent is the marking of the corresponding field in the Form and clicking on the submit button of the Form on any page of the Site;
- confirms that, by giving consent, he acts freely, by his own will and in his interest.

This consent is given to the processing of personal data both without use of the automation facilities, and with use of them.

Consent is given to the processing of the following User's personal data specified by the User in forms or in files attached to the forms:

- Last name, first name, patronymic;
- Position, organization;
- Telephone;
- City;
- E-mail;

- Other personal data specified by the User in forms or files attached to the forms.

The purpose of processing personal data is to store and use it for:

- Answers to Users' requests;
- Maintenance of the User's work with the Operator's Site;
- Sending Analytical Materials to Users and informing Users about upcoming events organized by the Operator, as well as registering Users for participation in such events;
- Contracting with the User.

By accepting the terms of this Consent, the User expresses his interest and gives total consent to the processing of his personal data including the following actions: collecting, recording, systematization, accumulation, storage, clarification (updating, modification), extraction, use, transferring (giving access), depersonalization, blocking, deletion, destruction of personal data.

The User's consent to the personal data processing is specific, informed and conscious.

This User's consent is recognized as executed in simple written form.

This consent shall come into force from the moment of data submission and can be recalled by the User by submitting a written application to the Operator with indication of the data specified in Article 14 of the Federal Law on Personal Data (No. 152-FZ) at 12 Obnodniy kanal, Arkhangelsk, office 501.

In case the User recalls the consent to the personal data processing, the Operator shall have the right to continue processing of the personal data without the consent of the User in the presence of the grounds mentioned in clauses 2-11 of part 1, Article 6, part 2, Article 10 and part 2, Article 11 of Federal Law on Personal Data (No. 152-FZ).

During the personal data processing, the Operator has the right perform the following actions: collection, record, filing, accumulation, storage, update (update, amendment), extraction, use, transfer (distribution, submission, access), depersonalizing, blocking, removal, destruction of the User's personal data.

The Operator shall have the right to amend this Consent at any time. When amending the current version, the date of the last update should be indicated. The new version of the Consent comes into force from the moment of its publication, unless otherwise provided by the new edition of the Consent.
